

Prior to the North Orange County Public Safety Collaborative, public safety officers, cities, and community-based organizations were all operating in silos trying to tackle issues in North Orange County.

The key takeaway and lesson learned from the North Orange County Public Safety Collaborative is that a coordinated response from each of these partners is critical to helping individuals exit homelessness and providing the right resources, for the right person, at the right time.

# MEASURABLE RESULTS OF THE COLLABORATIVE (FY 2017 - 2022)

### HOMELESS PREVENTION AND OUTREACH

### **Homeless Census**

Generated a by-name registry of 1,324 unsheltered individuals. 749 exited homelessness into housing. 613 have engaged in case management. This by-name registry allows service providers to work within HMIS software to effectively streamline the support for transient homeless individuals in order to match them with relevant care and housing.

### **Resource Map**

Development of an online mapping application to 1) Identify affordable housing and its application process; 2) Locate homeless service providers for appropriate services/resources linkages. The Resource Map is in development through the Social Science Research Center at Cal State Fullerton. The Map is intended for the general public and also by local government, affordable housing developers, outreach workers, public safety and public health workers.

#### **Innovative Solutions**

Established the first of its kind bed shelter reservation app to coordinate availability in local shelters to ensure that beds are available and ready for use in real time and using a Point of Work System that bring together "right people, right resources, right now".

### **Regional Hub**

Sponsorship of the HOPE Center as a regional hub for multi-jurisdictional and multi-disciplinary teams to coordinate responses, centralized resources and integrate data in the area of street homelessness. The HOPE Center is an evidence-based, data-driven and replicable model with a common agenda to end street homelessness with shared performance metrics.

> **The Bottom Line** Meaningful collaboration works, and leveraging technology is the mechanism for success.

### **REENTRY OF OFFENDERS**

### Housing

Established nation's first housing and support services for formerly incarcerated university students at Cal State Fullerton.

### **Hope Builders**

Pilot partnership with Orange County Conservation Corps and the Orange County Department of Education in creating career pathways for reentry of young adults from North Orange County. 70% have successfully completed the training curriculum and 90% have secured employment in career pathways that offer a living wage. 80% of the graduates retain their career pathway placement.

## YOUTH VIOLENCE PREVENTION AND **INTERVENTION IN K-12 SCHOOLS**

#### **Bigs with Badges**

Established a mentorship program with youth and law enforcement. 75% of youth that engaged with the program reported improved attitudes towards law enforcement.

#### **Supportive Services**

Funded 28 youth programs that included family counseling, supportive services, tutoring, group and individual counseling, and mentoring programs. Funding allowed already existing providers to expand services to additional school sites to broaden their reach.

### **Tri-City Podcast Teen Program**

Designed by Boys & Girls Clubs in North Orange County, the Tri-City Podcast Teen Program is a teendirected youth development podcast that weaves core elements of the Clubs' proven prevention and intervention techniques with a workforce development program that utilizes current technology communication tools.
